Good evening Jason,

I'm so thrilled that you would take the time and effort to send this email to WCS administrators. I'm honored to work with you and in this school district.

As you probably know, restorative justice practices are of the utmost importance to me. When I interviewed for my current job, I said over and over that the greatest thing we can do for at-risk/troubled teenagers is a provide a liminal space of restoration for them. As I've studied restorative practices extensively over the past few years and implemented circles, conferences, and mediation at the ALC, I see that the work reaches far beyond what we do in our small corner of the county.

There are several ways to strengthen community on a large scale that involves restorative work. I attend the IIRP world conference back in Oct 2019 in Bethlehem, PA and one of my favorite sessions was about "listening circles". When the Boston community went through all they did with the sexual abuse crisis in the Catholic Church, restorative practitioners held "listening circles" to give victimized people a voice to be heard. This could be one method we use, as appropriate, when we identify students/faculty/etc who have a need to air frustrations and hurt: a "listening circle" for those most affected by the violence, protests, etc. Just an idea. I'd love to help facilitate.

Finally, I'm glad you chose the language of dignity in your email. Zannie Martin, Drason Beasley (our JDC supervisor), and I have normed our language to use this word when training our staffs on how to treat our students and families. Our goal is to give each young person the dignity they are born with. There's a great article that I'll attach here that I've used in our trainings over the years called "The Science of Human Dignity". It comes from the president of the IIRP and highlights that all people have the same 3 basic needs: the need to belong, the need to have voice, and the need to exercise agency. It's a great read, and I urge you to spend some time with it.
